


Figure 1a. Relative survival of patients with bone cancer by period of diagnosis. Included in the evaluation are 327 cases diagnosed between 1978 and 2011.

The survival results of the SEER program (Surveillance, Epidemiology, and End Results) of the American National Cancer Institute (NCI) are summarized as the period of diagnosis from 1998 to 2009, and are represented by green diamonds in order to facilitate comparisons between MCR and SEER

The presented survival curves are derived from clinical records with valid follow-up informations, which means that death certificate cases (DCO) cases are omitted from the analysis. With this one restriction, the MCR has provided population-based statistics since 1998, collecting data on all cancer cases in the region of southern Bavaria. Historical data of previous time periods can be heavily selected, therefore, univariate survival comparisons of the presented time periods must be carefully considered. Nonetheless, all calculable survival curves are depicted to facilitate the comparison of long time follow-up analyses of relative survival between particular cancers.




Figure 2a. Survival of patients with bone cancer by gender. Included in the evaluation are 285 cases diagnosed between 1988 and 2011.




Figure 3a. Relative survival of patients with bone cancer by age category. Included in the evaluation are 285 cases diagnosed between 1988 and 2011.




Figure 4a. Relative survival of patients with bone cancer by TNM staging. For 122 of 285 cases diagnosed between 1988 and 2011 valid data could be obtained for this item. The accumulated percentage exceeds the 100% value because patients are potientially considered in more than one subgroup. The grey line represents the subgroup of 163 patients with missing values regarding TNM staging (57.2% of 285 patients, the percent values of all other categories are related to n=122).




Figure 5a. Observed post-progression survival of 144 patients with bone cancer diagnosed between 1978 and 2011 (incl. M1). These 144 patients with documented progression events during their course of disease represent 44.0% of the totally 327 evaluated cases. Patients with cancer relapse documented via death certificates only were excluded (n=13, 4.0%). Multiple progression types on different sites are included in the evaluation even when not occurring synchronously. The NOS (not otherwise specified) class is included under the condition, that it is the one and only progression type during the course of disease. Subgroups with sample size <15 are dropped from the chart.

Medical record documentation often lacks the linguistic severity to distinguish between local relapse, regional lymph node metastasis and distant spread in solid cancers. Frequently, the statement "not specified" is the only information in registries regarding relapse of the disease. The category "All types" denotes all cases who suffered from at least one relapse during the course of disease (incl. primary M1-status). Although, the real number of relapsed patients is likely to be much higher. The accumulated percentage of patients with local relapse or distant metastasis exceeds the 100% value because patients are potientially considered in more than one subgroup.
